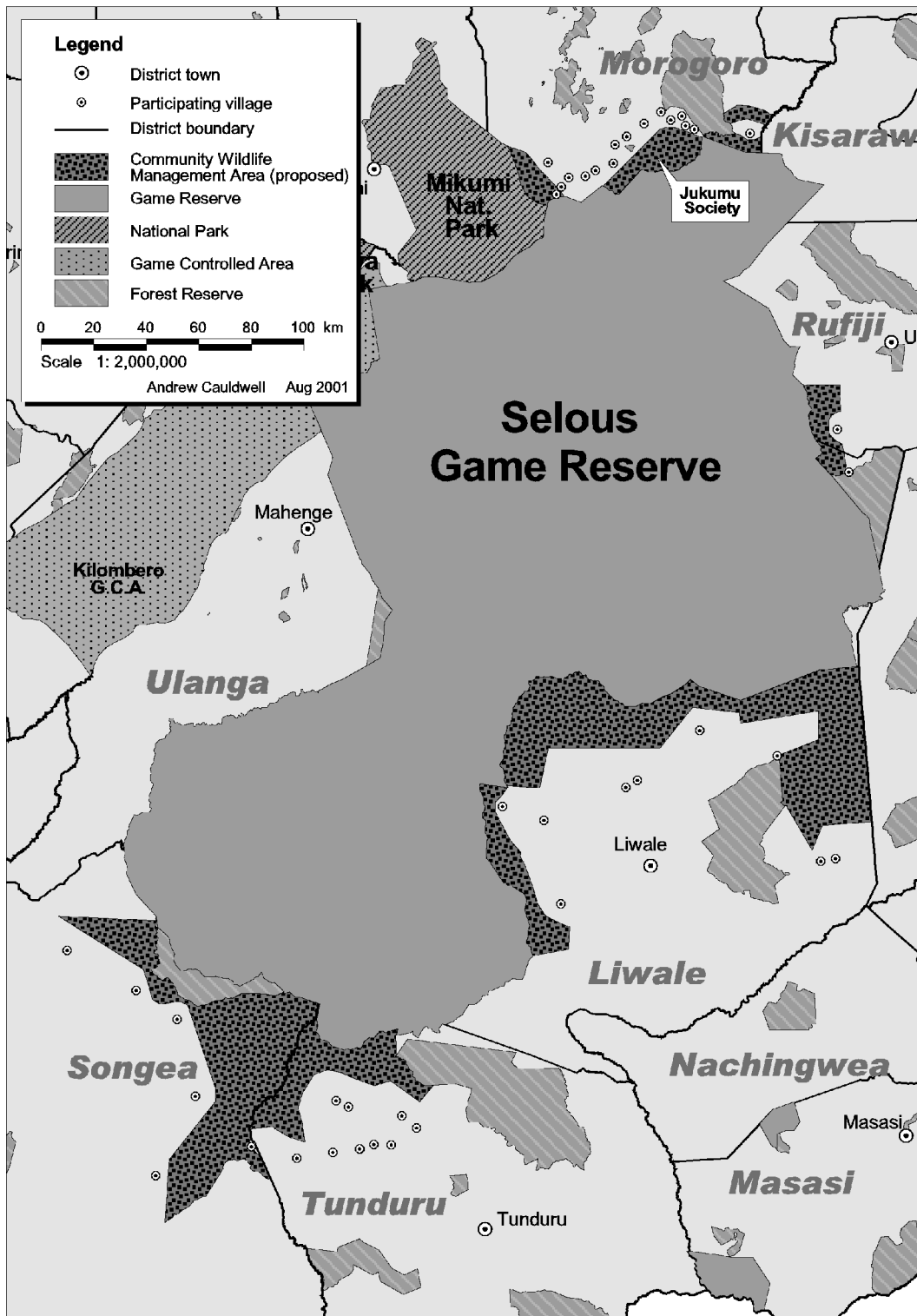


## Community Wildlife Management Areas (proposed) of the Selous Conservation Programme





## **INFORMATION ON THE COMMUNITY BASED CONSERVATION TRAINING CENTRE IN LIKUYU SEKAMAGANGA, TANZANIA**

The meanwhile national Community Based Conservation Training Centre (CBCTC) was established in July 1995 by the Wildlife Division in co-operation with the Selous Conservation Programme (SCP/GTZ). The Centre is located at Likuyu Sekamaganga, a village South of the Selous Game Reserve and 100 km from Ruvuma regional capital, Songea. It was created to train people from rural communities in the management of natural resources, especially wildlife.

Located in the bush, close to one of the Selous Sector Stations in a wildlife area, the CBCTC is at the heart of what community conservation is about: The area between Selous and the Centre is a Village Wildlife Management Area and forms part both of the Southern buffer zone of the Selous as well as of the Selous-Niassa wildlife corridor. For the course participants, coming from all over Tanzania, the Centre and the surrounding villages are a platform for discussion and exchange of ideas, next to the practical experience obtained on the course in subjects such as problem animal control and anti-poaching.

The Centre is organised around three professional staff supported by external lecturers. It is self-financing through course fees.

### **Courses Currently Offered:**

- A Village Game Scout Training Course, which focuses on practical fieldwork.
- A Community Based Conservation Training Course for Village Leaders, Natural Resources Committees and Community Based Organizations.

The Institute also offers tailor made courses on demand. The maximum number of participants per course is 40. All participants must have completed primary education. All courses are conducted in Swahili. Participants have to pay a course fee which is presently 250 000 TSh for the Village Game Scout Course and 140 000 TSh for the Village Leaders Course.
